Discuss and consider minutes: Director Templeton made a motion to accept the minutes. Director Slater seconded. All in favor. None opposed. Motion carried.

Report by Dirk Poeschel: Mr. Poeschel reported on the status of the environmental impact report document. Director Richards thanked Mr. Poeschel for his efforts and diligence in securing the finalization of the environmental impact report.

Chair Report: Director Dougherty stated he consulted with the Fresno Chaffee Zoo Corporation attorneys regarding the vacant CEO's duties during the hiring process. Director Dougherty stated the Board will be assuming the CEO duties until the position has been filled.

CEO Report: CEO Greene reported that the zoo has a new male Malaysian Tiger. The zoo also has received 6-banded armadillos. CEO Greene stated that the recent birth of the baby addax marks the 38th born to this zoo. CEO Greene reported with sadness the loss of "Anacapa" the zoo's young sea lion, which was paralyzed in her hind quarters. CEO Greene noted the heroic efforts of the zoo staff to give the best quality of life for the animal. CEO Greene stated that the education department will be receiving a sprinter van for the zoomobile program. CEO Greene announced the re-opening of Tropical Treasures in the Maddis House on March 7, 2009. CEO Greene stated the "pay like a kid play like a kid" marketing campaign that ran December 2008 through January 2009 was a success.

Report by Director of Finance and Administration: Mr. Goldman reviewed the financial statement with the board.

Discuss and consider budget amendment, request for capital funds: Director of Marketing and Development, Brian Goldman requested a \$400,000 increase to the capital funds budget. Director Rainwater made a motion to accept the budget increase as requested. Director Nokes seconded. All in favor. None opposed. Motion carried.
