Discuss and consider minutes: Director Templeton made a motion to accept the minutes as written. Director Richards seconded. All in favor. None opposed. Motion carried.

CEO Barton stated the Zoo budget was approved unanimously by the Zoo Tax Authority. CEO Barton stated the zoo staff are working on and applying for several grants. CEO Barton stated the Zoo would be receiving 2 young female sea lions. CEO Barton further stated these young sea lions had been released back to the wild without success. Director Richards reported the Nominating Committee had met and have a recommendation to fill the seat vacated by former Director Cruz Ramos.

Report by Director of Finance and Administration: Mr. Goldman reviewed the financial statements with the board.

Director Templeton reported the Finance Committee had met and reviewed the accounts and formed a plan on how best to proceed in the next year. Director Nokes made motion to accept the report as given by Director Templeton. Director Manning-Cartwright seconded. All in favor. None opposed. Motion carried.
