Meeting called to order at 5:34 p.m.

Discuss and consider minutes: Director Templeton made a motion to accept the minutes as amended. Director Rainwater seconded. All in favor. None opposed. Motion carried.

Chair Report: Director Dougherty stated there was a slight change to the agenda. The board approved to add resolution item #7A to allow Colin Dougherty to sign all documents necessary to purchase property on Belmont Avenue. Director Dougherty stated everyone is very busy with the new Sea Lion Cove exhibit it is looking spectacular.

Director Richards stated the Audit Committee met with Nora Crow of Moore Grider.
